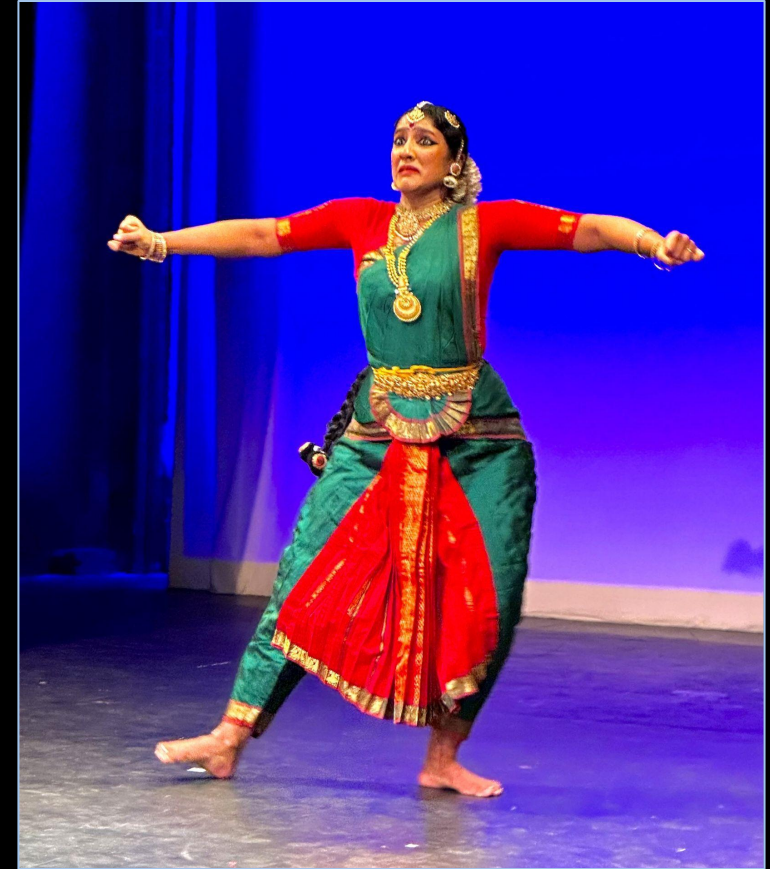

ARTCOOP will be the first-ever **dedicated performing arts center for diverse small theatre and dance companies** , with annual budgets under \$500,000.

It will provide a **stable, long-term home enabling extraordinary growth and sustainability** by offering affordable performance venues, rehearsal spaces, shared office environment, and a permanent space that can give so many companies a chance to grow and thrive.

In a post-COVID landscape where many smaller companies have been displaced or shuttered, **ARTCOOP will fill a critical gap**, creating a bridge between emerging artists and the vital need for these companies to have a place to call home.

ARTCOOP will be a necessary step in connecting the next generation of theatre-makers and choreographers and will serve as a dynamic incubator for bold and exciting new works.

EXECUTIVE SUMMARY



For your tax-deductible support, **naming opportunities** are available, offering a lasting legacy for those individuals and foundations who understand the incredible need for a performing artists center devoted to these smaller theatre and dance companies.

This is more than a real estate project—it is a commitment to the future of the arts. **Your investment will transform lives, empower diverse voices, and revitalize New York City's artistic landscape.**

THE CASE FOR SUPPORT

- **POST-COVID CRISIS** : Many small theatre companies have closed due to rising costs and displacement. Some companies, like Emerging Artists, which have been around for over 30 years, still do not have a permanent home that will allow the artists to see their creativity come alive on stage.
- **LACK OF INFRASTRUCTURE:** New York City has no dedicated performing arts center for small theatre and dance companies. Current venues are **rental-only** without long-term support, and many are beyond the budgets of these smaller companies.
- **A PROVEN MODEL FOR SUCCESS:** Emerging Artists Theatre has already demonstrated the **power of an incubator model**, launching numerous productions from development to Off-Broadway success (*The Sensational Josephine Baker*, *Penny Penniworth*). ARTCOOP will scale this model to serve multiple companies at once.





PROJECT PLAN & TIMELINE

PHASE 1: BUILDING ACQUISITION (First 6 Months)

- Purchase property in New York City (contact us for further details)
- Conduct architectural planning with **Nestor Bottino, Architect,** and developer **Roland Dib**

PHASE 2: RENOVATIONS & CONSTRUCTION (3-6 Months)

- Convert the space into a state-of-the-art performing arts center, including:
 - **Four 99-seat theatres**
 - **10 rehearsal rooms**
 - **Shared office space**

PHASE 3: PROGRAM LAUNCH & SUSTAINABILITY PLAN

- Open doors to resident theatre and dance companies by having a core group of anchor companies with long term success and a large array of smaller theatre and dance companies as resident companies.
- Establish ARTCOOP as a **hub for fostering new diverse work in the areas of plays, dance, musicals, and solo work.**

PROGRAMMING & IMPACT



ARTCOOP WILL PROVIDE:



- **AFFORDABLE PERFORMANCE SPACES**— Four ninety-nine-seat theaters for 10-20 small theatre and dance companies.
- **REHEARSAL & DEVELOPMENT RESOURCES**—10 studios and shared offices to foster artistic collaboration.
- **A SUSTAINABLE BUSINESS MODEL**— Revenue through rentals, ticket sales, and grants will ensure long-term success.

By eliminating financial and logistical barriers, ARTCOOP will **empower a multicultural, diverse cornucopia of artists**, shaping the next generation of theatre and dance.

KEY LEADERSHIP



PAUL ADAMS

Founder & Artistic Director, Emerging Artists Theatre

Paul Adams founded Emerging Artists Theatre in 1993 and has been the Artistic Director for the life of the company. During this time, EAT has premiered hundreds of new works (plays, solo shows, musicals & dance pieces) for Off and Off-Off Broadway. Some of his favorite credits include directing the Off-Broadway production of *Sisters' Dance* by Sarah Hollister at Baruch Theater and producing the solo show *The Sensational Josephine Baker* by Cheryl Howard, which had two Off-Broadway runs at Theatre Row and received a rave review in the NY Times. Paul performed his critically acclaimed solo show, *The Cleaning Guy*, at FringeNYC in 2016. He has also served on the NY Innovative Theatre Awards committee since its inception. Paul recently made his Off-Broadway debut as a playwright with *Doris Day: My Secret Love*.





ROLAND DIB
